Important Information to Consider:

- This course pathway will take one (1) year to complete
- Students will be required to purchase basic tools & personal protective equipment (PPE) not covered by Dual Enrollment funding
- Students must provide their own transportation to the LTC Campus
- Students must complete a LTC Dual Enrollment application and apply for one of the Diesel Equipment Programs
- Deadline to apply and have all admissions information complete is April 1, 2025, to be considered in the Diesel Equipment Course Pathway selection process at Hall Campus

Dual Enrollment - Diesel Equipment Course Selection (Hall Campus) Students MUST, to be considered, complete the following items by

<u>April 1, 2025</u>

- Students must commit to the course pathway & class times for DE students as presented via the pathway program flyer for Hall Campus. Any other course variations will not be granted
- Students must complete the LTC application for admissions for Fall Semester 2025, for one of the Diesel Equipment programs on our website. <u>Diesel Equipment Technology</u>
- Students MUST ensure their in-progress high school transcript, placement requirements, residency (if Self/Split/HOPE paying), or any other item required for the application to be complete is submitted, as requested. You can check your Admissions Portal checklist here: Lanier Technical College (site.com)
- Students MUST complete their GAfutures Dual Enrollment Funding application, and parents/guardians MUST also complete with parent/guardian signature. You may check your status here: <u>GAfutures.org</u> | <u>Georgia Student Finance Commission</u>
- If you are an Accelerated Career Diploma student, you MUST complete the GSFAPPS found here: <u>GSFAPP Student Application (gafutures.org)</u>
- Students MUST be registered for Selective Service if 18 years of age or within 30 days of their 18th birthday
- Students MUST be in good standing at the college and not be on academic dismissal or financial aid suspension
- Acceptance to the program **does not guarantee** selection for the course pathway; instead, it allows students to enter into the course pathway selection.
- ONLY students whose application requirements above are met and are deemed accepted will be entered into the course pathway selection.

Course Pathway Selection Information

- Four (4) seats total are available for the Diesel Equipment program at the Hall campus
- Selection will take place on April 3, 2025. For each eligible student who has completed all admissions criteria above, the name of the high school the student attends, not the individual student's name, will be submitted for a random selection process.
- LTC will randomly select from the entries the number of slots each high school location will receive*
- LTC will contact each high school to notify them of the number of slots allocated to them*
- The high school will provide LTC with the names of the students they have selected for admission into the program*
- Once provided, the Dual Enrollment Coordinator will register the student identified by the high school for the first course/courses in the pathway

* A school system may elect to determine which high school in their system will receive the selected seats
